- 2.2 Balloting will be used to determine the order of priority in selection of the specified residential properties within each Round of Selection. Details are as follows.

- 2.3 A registrant shall attend the designated venue in person between 6 p.m. and 6:30 p.m. on the First Date of Sale (the “Attendance Registration Period”). The registrant must bring along (i) a copy of each of the completed and submitted Registration of Intent, blank cheque(s) and H.K.I.D./passport (for individual registrant) OR (ii) a copy of each of its completed and submitted Registration of Intent, blank cheque(s), a copy of Business Registration Certificate, a copy of the most updated annual return of the company and the company chop (for corporate registrant).
