General provisions: 一般規定：</p> <p>1.1 Where more than one specified residential property is covered in one preliminary agreement for sale and purchase, the purchaser of each such specified residential property shall comprise the same person or the same group of persons. 如同一份臨時買賣合約包括多於一個指明住宅物業，每一該等指明住宅物業之買方須由同一人士或同一組人士構成。</p> <p>1.2 “Entire Floor Properties Combination” means all three units on the same floor of a Tower.</p>

1.3 “Same Floor 2 Properties Combination” means any two units on the same floor of a Tower.

2. First Date of Sale:

2.1 First come first served, subject to the provisions below.
先到先得，下文另有規定除外。

2.2 All interested persons who are present in the designated venue as at the beginning of the Time of the Sale of the First Date of Sale will be regarded as all having come to the designated venue at the same time at the beginning of the Time of the Sale. Any such person who indicates an intention to purchase any one or more specified residential properties which any one or more other such persons also indicate an intention to purchase will be grouped into a group for determining the order of priority in selection of specified residential properties (the “Group”). Any person in the Group will be referred to as a Group Participant.

於出售日期出售時間開始當時所有身處指定會場之有意認購的人士將被視作同時於出售日期出售時間開始當時到達。如一位該等人士所表示意欲購買之一個或多個指明住宅物業亦是其他任何一位或多位該等人士所表示意欲購買之指明住宅物業，該人士將歸入一組（下文稱作「該組別」）內以決定揀選指明住宅物業的優先次序。歸入該組別的人士稱作「組別參與人」。

2.3 The priorities in the selection of specified residential properties among the Group Participants are as follows:

2.4 Where the priority among two or more Group Participants according to paragraph 2.3 above are the same, balloting will be used to determine the order of priority in selection of the those specified residential properties among such Group Participants. Each such Group Participant shall be allotted with one lot. The balloting results will be announced by means as the Vendor considers appropriate at the designated venue. The Group Participants concerned will not be separately notified of the balloting results.
