The method to be used to determine the order of priority in which each of the persons interested in purchasing any of the specified residential properties may select the residential property that the person wishes to purchase:

1. General provisions:
一般規定：

- 1.1 Where more than one specified residential property is covered in one preliminary agreement for sale and purchase, the purchaser of each such specified residential property shall comprise the same person or the same group of persons.
如同一份臨時買賣合約包括多於一個指明住宅物業，每一該等指明住宅物業之買方須由同一人士或同一組人士構成。
- 1.2 “Entire Floor Properties Combination” means all three units on the same floor of a Tower.

- 1.3 “Same Floor 2 Properties Combination” means any two units on the same floor of a Tower.
「同層雙物業組合」指一座中之同一層之任何兩個單位。
- 1.4 In case of any dispute, the Vendor reserves its right to allocate any specified residential properties to any interested person by any method (including balloting).

2. First Date of Sale:
出售首日：

- 2.1 First come first served, subject to the provisions below.
先到先得，下文另有規定除外。
- 2.2 All interested persons who are present in the designated venue as at the beginning of the Time of the Sale of the First Date of Sale will be regarded as all having come to the designated venue at the same time at the beginning of the Time of the Sale. Any such person who indicates an intention to purchase any one or more specified residential properties which any one or more other such persons also indicate an intention to purchase will be grouped into a group for determining the order of priority in selection of specified residential properties (the “Group”). Any person in the Group will be referred to as a Group Participant.
於出售首日出售時間開始當時所有身處指定會場之有意認購的人士將被視作同時於出售首日出售時間開始當時到達。如一位該等人士所表示意欲購買之一個或多個指明住宅物業亦是其他任何一位或多位該等人士所表示意欲購買之指明住宅物業，該等人士將歸入一組（下文稱作「該組別」）內以決定揀選指明住宅物業的優先次序。歸入該組別的人士稱作「組別參與人」。

- 2.3 The priorities in the selection of specified residential properties among the Group Participants are as follows:

- 2.4 Where the priority among two or more Group Participants according to paragraph 2.3 above are the same:

若根據上文第2.3段兩名或以上組別參與人之揀選指明住宅物業優先次序相同：

- (a) the Group Participant who indicates to purchase specified residential property(ies) having a higher total Price will have a higher priority to select those specified residential property(ies); and
其所表示意欲購買之指明住宅物業之總售價較高之組別參與人將就揀選該等指明住宅物業有較高之優先次序；及
- (b) where two or more Group Participants indicates to purchase specified residential property(ies) of the same total Price, balloting will be used to determine the order of

priority in selection of the those specified residential properties among such Group Participants. Each such Group Participant shall be allotted with one lot. The balloting results will be announced by means as the Vendor considers appropriate at the designated venue. The Group Participants concerned will not be separately notified of the balloting results.

若兩名或以上組別參與人所表示意欲購買之指明住宅物業之總售價相同，該等組別參與人之間揀選該等指明住宅物業之優先次序將以抽籤方式決定。每位該等組別參與人可獲分配一個籌。抽籤結果將會以賣方認為合適之方式於指定會場公布。該等組別參與人將不獲另行通知抽籤結果。

The Price of a specified residential property means the listed price of it as set out in Part 2 of the latest effective price list including that specified residential property.

3. On the day following the First Date of Sale and thereafter:

First come First served. Persons interested in purchasing must personally attend the designated venue. The Vendor does not accept any person interested in purchasing having queued up before the Time of the Sale on the date concerned.

- (a) Prospective purchasers will be offered to view the selected specified residential property(ies), or a comparable residential property if it is not reasonably practicable for the selected specified residential property(ies) to be viewed by the prospective purchasers, before entering into the preliminary agreement for sale and purchase.
