The Purchaser may apply to "Winchesto Finance Company Limited", the second mortgagee referred by the Vendor or any other company referred by the Vendor (the "Referred Second Mortgagee") for second mortgage with a maximum loan amount equivalent to 20% of the Transaction Price or 20% of the valuation of the property (as determined by the Referred Second Mortgagee) (whichever is lower) (the "Second Mortgage").
