## 1. General provisions:

- 1.1 Where more than one specified residential property is covered in one preliminary agreement for sale and purchase, the purchaser of each such specified residential property shall comprise the same person or the same group of persons.

- 1.2 "Entire Floor Properties Combination" means all three units on the same floor of a Tower. 「全層物業組合」指一座中之同一層之全部三個單位。
- 1.3 "Same Floor 2 Properties Combination" means any two units on the same floor of a Tower. 「同層雙物業組合」指一座中之同一層之任何兩個單位。

- 2.2 All interested persons who are present in the designated venue as at the beginning of the Time of the Sale of the First Date of Sale will be regarded as all having come to the designated venue at the same time at the beginning of the Time of the Sale. Any such person who indicates an intention to purchase any one or more specified residential properties which any one or more other such persons also indicate an intention to purchase will be grouped into a group for determining the order of priority in selection of specified residential properties (the "Group"). 2.4 Where the priority among two or more Group Participants according to paragraph 2.3 above are the same:
