

## 第 52(1)條 / Section 52(1)

在某人就指明住宅物業與擁有人訂立臨時買賣合約時,該人須向擁有人支付售價的5%的臨時訂金。 A preliminary deposit of 5% of the purchase price is payable by a person to the owner on entering into a preliminary agreement for sale and purchase in respect of the specified residential property with the owner.

#### 第 53(2)條 / Section 53(2)

如某人於某日期訂立臨時買賣合約,並於該日期後的5個工作日內,就有關住宅物業簽立買賣合約,則擁有人必須在該日期後的8個工作日內,簽立該買賣合約。 If a person executes an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase, the owner must execute the agreement for sale and purchase within 8 working days after that date.

#### 第 53(3)條 / Section 53(3)

如某人於某日期訂立臨時買賣合約時,但沒有於該日期後的5個工作日內,就有關住宅物業簽立買賣合約,則 – (i)該臨時合約即告終止;(ii)有關的臨時訂金即予沒收;及(iii)擁有人不得就該人沒有簽立買賣合約而針對該人提出 進一步申索。

If a person does not execute an agreement for sale and purchase in respect of the residential property within 5 working days after the date on which the person enters into the preliminary agreement for sale and purchase-(i) the preliminary agreement is terminated;(ii) the preliminary deposit is forfeited; and (iii) the owner does not have any further claim against the person for the failure.

- 3. 5% of the Transaction Price shall be paid within 60 days after the Purchaser signs the preliminary agreement for sale and purchase.

- 2. 成交金額 5% 加付訂金於買方簽署臨時買賣合約後30天內繳付。
- 3. 成交金額 5% 於買方簽署臨時買賣合約後90天內繳付
- 4. 成交金額 5% 於買方簽署臨時買賣合約後180天內繳付。
- 5. 成交金額 7.5% 買方分30期每月支付,每期金額均等(即每期為成交金額0.25%),第一期於買方簽署臨時買賣合約後第181天(「第一期付款日」)繳付,之後每一月份同日繳付一期(唯受下文「提前付清成交金額餘款」 條款限制)

## 「提前付清成交金額餘款」條款:

- 如買方欲於「餘額付款日」前全數付清當其時之成交金額餘款,買方可於「第一期付款日」後但於「餘額付款日」前之一個月份同日之前任何時間向賣方發出書面通知,發出該通知後買方須於該通知日期後之一個月份同日 (i) 付清當其時之成交金額餘款。

- 2. 5% of the Transaction Price being the Further Deposit shall be paid within 30 days after the Purchaser signs the preliminary agreement for sale and purchase.
- of the Transaction Price shall be paid within 90 days after the Purchaser signs the preliminary agreement for sale and purchase. 3. 5%
- 4. 5% of the Transaction Price shall be paid within 180 days after the Purchaser signs the preliminary agreement for sale and purchase.

- (i) Should the Purchaser wish to pay the then remaining balance of the Transaction Price earlier than the Balance Payment Date, the Purchaser may at any time after the First Instalment Payment Date but before the date falling one calendar month before the date of the Balance Payment Date issue a written notice to the Vendor in which case the Purchaser shall pay the then remaining balance of the Transaction Price on the date falling one calendar month after the date of that notice.
